

# Ascend Schedules 75th Annual Meeting & Board of Directors Election

**Meeting to be held Saturday, March 21, 2026, at 1 p.m.**

The Nominating Committee for the Ascend Board of Directors has submitted nominations for three Board seats to be filled in 2026. Biographical data on nominees P. David Elrod, Ramon J. Guzman, and Anthony J. Taylor are included.

Nominations by petition must be submitted to the secretary of the Board of Directors no later than 5 p.m. on Tuesday, Feb. 10, to qualify. Nominations by petition must be signed by 1% of the membership (minimum of 20 and maximum of 500 signatures). Biographical data and a signed “Notice of Willingness to Serve” must accompany petitions.

In the event that no nominating petitions are filed by the general membership, nominees submitted by the Nominating Committee will be elected by acclamation. In this case, according to the by-laws, a mail ballot is not required.

Nominations will not be accepted from the floor at the Annual Meeting if there is at least one nominee for each position to be filled.

The results of the 2026 Annual Election will be announced at the 75th Annual Meeting, scheduled for 1 p.m. Saturday, March 21, and will be held in the Apollo Conference Room at Ascend Headquarters in Tullahoma.
