# Protect Yourself (and Your Money) from Scammers

We live in an increasingly digital world and while accessibility helps make activities quick and convenient, having so much of our personal information online leaves us vulnerable to cyber criminals. Here are a few things you can do to boost your financial security:

- Beware of spoofing:** One of the most common tactics scammers use is spoofing, where they appear to be a trusted organization, such as a financial institution or a government agency, on your caller ID or email and ask you for important personal or account information. Remember to never share your private information until you can verify the legitimacy of whoever is contacting you. If you are an Ascend member and receive a suspicious message or phone call that appears to be from Ascend, call 800-342-3086 to confirm the validity of the message before responding.
- Watch what you share:** It's important to limit the personal information you share on social media. This includes answers to common security questions, such as your mother's maiden name or the make and model of your first car, your address, and images of sensitive documents like your driver's license or passport.
- Be skeptical of unrealistic promises:** Be cautious of offers that sound too good to be true, like guaranteed loans, prize winnings, or investment opportunities. Scammers often use these tactics to lure you into sharing sensitive information or sending money.
- Monitor your accounts:** Regularly monitor your bank and credit card accounts for unusual activity. Set up account alerts inside Ascend Digital Banking so you're notified of transactions right away, and report anything suspicious immediately. Furthermore, Ascend Digital Banking also allows you to receive free credit monitoring through SavvyMoney, notifying you when new accounts are opened or when credit inquiries are made.

Protecting your money starts with staying informed and cautious. By being proactive and skeptical of unexpected requests, you can outsmart scammers and keep your finances secure.

# 74th Annual Meeting

March 29, 2025



## Opening Remarks

Chairman Mark Rigney welcomed attendees to Ascend Federal Credit Union's 74th Annual Meeting. On behalf of Ascend's Board of Directors, Chairman Rigney expressed his sincere appreciation to our more than 250,000 members for their continued trust and loyalty to Ascend, and expressed his gratitude to the more than 600 employees who continue to put the members' needs first.

Chairman Rigney noted every decision made at Ascend is guided by the mission — to be a trusted partner in the members' financial journeys and a force for good in the communities served. Ascend continued to put that mission into action through new checking products that provided over \$4 million back to members; small-dollar, short-term loans; and competitive rates on deposit and loan products. Ascend also helped members strengthen their financial health by providing hands-on workshops, one-on-one financial counseling, and free credit monitoring tools. Additionally, Ascend established partnerships with local schools to provide age-appropriate financial literacy curriculums to more than 30,000 K-12 students across Middle Tennessee.

Beyond the financial services offered, Ascend continued to serve and uplift communities by giving time and resources. In 2024, Ascend contributed over \$1.4 million back to local organizations and invested in the next generation by awarding \$42,500 in scholarships to members and local students pursuing higher education.

Ascend remains a financially stable institution, and the members' satisfaction reflects that. In 2024, the average Net Promotor Score (NPS) was 74.5 — far exceeding the consumer banking industry average of 33. In addition, Ascend experienced strong financial growth, increasing assets by more than \$158 million in the past year. These numbers are a testament to the trust members place in the credit union and the value Ascend continues to provide.

Prior to officially calling the meeting to order, Chairman Rigney reminded meeting attendees of the door prizes being presented following this meeting.

The annual meeting was called to order by Chairman Rigney on March 29, 2025, at 1:04 p.m. in the Apollo conference room of Ascend in Tullahoma, Tennessee.

In addition, Chairman Rigney recognized Ascend President & CEO, Matt Jernigan. Mr. Josh Johns, Supervisory Committee Chairman, reported a quorum was present and in attendance for this meeting.

## Approval of Minutes

Chairman Rigney announced the minutes of the Annual Meeting held on April 6, 2024, were distributed in the summer issue of Possibilities. The floor was opened for questions and/or comments. There being none, a motion was made by Mr. Taylor and seconded by Ms. Marshall to approve the minutes dated April 6, 2024, as written. The motion carried unanimously.

## Reports of Chairman, Treasurer, and Supervisory Committee

Election Results - Chairman Rigney reported there were no qualifying petitions received this year; therefore, in accordance with the credit union's Bylaws, the nominees presented by the Nominating Committee were elected by acclamation. Officials elected for a three-year term were Ms. Valerie Molette, Ms. Tonya Quarles, and Mr. Mark Rigney.

## Adjournment

The floor was opened for questions and/or comments. There being no questions or further business, Chairman Rigney asked for a motion to adjourn the meeting at 1:07 p.m. A motion was made by Ms. Quarles and seconded by Mr. Taylor to adjourn the 74th Annual Meeting of Ascend Federal Credit Union. The motion carried unanimously.

## Closing Remarks

Chairman Rigney expressed his appreciation to Ascend's staff and management for their hard work and dedication to Ascend. Chairman Rigney noted Ascend's staff continues live up to the core values — integrity, respect, excellence, generosity, relationships, and service — each and every day. In addition, Chairman Rigney expressed his appreciation to Ascend's Board of Directors. Last year, the Board elected to return \$3.5 million to the members in the form of bonus dividends and loan interest refunds. Combined with the \$4 million distributed from the checking products, over \$7.5 million was put back into the pockets of Ascend members. Since 2005, Ascend has returned more than \$116.5 million to members, demonstrating the ongoing commitment to share the success of the credit union with the member-owners.

On behalf of the volunteers and staff, Chairman Rigney thanked everyone for their attendance, support, and membership.
